## Key Features and Highlights

### Aspirant and Business registration

- Existing business users can register and add their organization details to seamlessly avail Goa government services and various central and state government schemes.
- Aspirant users or citizens can register to view facilities provided by the government and the approvals required to set up a business.

### Single Sign-On with Goa Online

- Aspirants and Entrepreneurs with existing Goa Online accounts can directly login to UDP using their Goa Online login credentials without creating additional account on UDP.
- Seamlessly apply for 83 Goa Online services provided by various departments, through the UDP portal without creating a separate account on or navigating through the Goa Online Portal.

### Single Sign-On with Entity Locker

- Aspirants and Entrepreneurs with existing Entity Locker accounts can directly login to UDP using their Entity Locker login credentials without creating additional account on UDP.
- All documents issued to the user in Entity Locker and uploaded by the user will be automatically fetched and synced with UDP to ensure ease of access.

## Single Window Deregulation

- **Know Your Approvals wizard** – helps a user to identify the approvals required from the government departments, by asking simple questions regarding their business.
- The wizard guides the user with links to the necessary online application forms for the various approvals and tracks each KYA request.

## Schemes Wizard

- The Schemes Wizard helps a user to identify the various Central and State Government schemes that the user is eligible for, by asking simple questions regarding their business.
- Profile-based scheme recommendations are provided to the user based on the complete profile information updated by the user.

## Documents Repository

- All documents issued to the user or uploaded by the user in Goa Online will be automatically fetched and synced with UDP to ensure ease of access.
- Entity Locker Documents synced with UDP will also be visible in the Document Locker.
- User can also upload additional documents into the UDP Documents Repository.
- Central management of all documents enables seamless application for various services and approvals.

## Integrated Training Management

- **UDP portal incorporates the various training programs facilitated by different government departments under a single platform, enabling the users to easily access relevant trainings for their business.**
- **Users receive all updates and manage their trainings through a single platform.**
- **Training Agencies can login and manage their respective trainings via the same platform, eliminating offline activities and reducing manual effort in the process.**
- **Integrated Dashboards track success metrics for the trainings and measure impact of various initiatives, enabling real-time reporting and analysis.**

## Reports and Analytics

- **Reports & Analytics dashboard presents live and periodic statistics about MSMEs in Goa - supporting transparency, strategic decision-making, and RAMP Programme monitoring.**

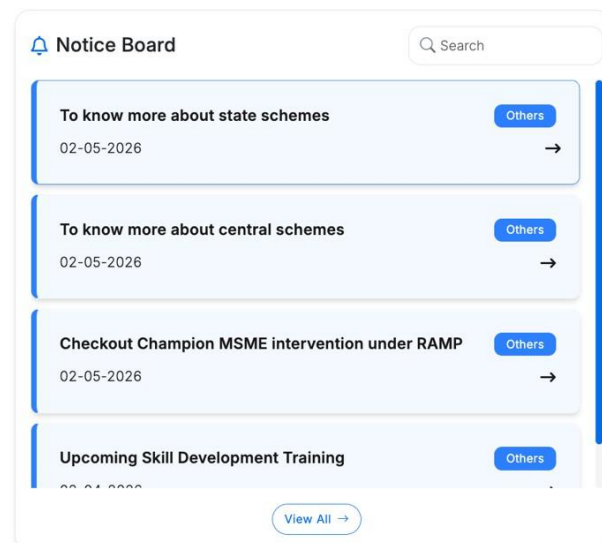

### Unified Digital Platform

The Government of Goa aims to design a **Unified Digital Platform** for the MSMEs in the state which shall act as a digital **one-stop solution** for MSMEs in Goa. The primary objective is to provide comprehensive **360-degree assistance to MSMEs** through a data-driven approach. It has been observed that the uptake of MSMEs in Goa has been relatively low in both **Central & State Government Schemes** for the MSME sector. The primary reason for the same is lack of awareness and limited clarity on the compliances and procedures to avail benefits under the various schemes. To address this challenge, a **unified digital system** will be created for disseminating information about the various MSME schemes and providing assistance in compliance/procedures through a digitized mechanism. The Portal will have various modules including the **Information, Application, Compliance, Training, and Online Dispute Resolution Module**. The Portal will also play a significant role in monitoring, tracking, and reporting the progress of various interventions under the RAMP Programme. This **RAMP monitoring dashboard** will help in course correction and strategic decision-making.

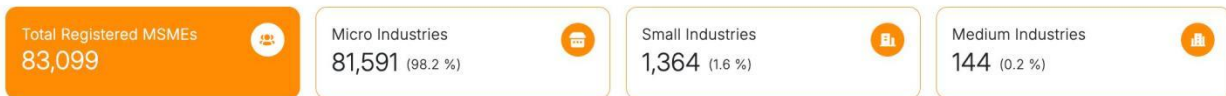

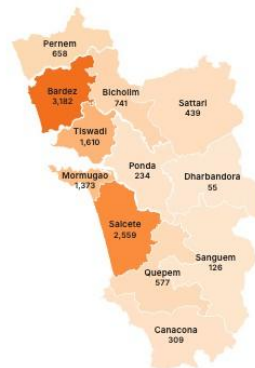


**Goa**, spread across about **3,702 sq km**, is India's smallest state by area, yet one of its most vibrant states, known for its beaches, Portuguese heritage, and unique blend of Indian and Western culture. Goa is often called the "**Pearl of the Orient**" or "**Tourist Paradise**". Goa became a state on **30th May 1987**, after previously being part of the union territory of Goa, Daman, and Diu.

Goa is situated on the western coast of India, along the Arabian Sea. Goa's **131 km** coastline attracts millions of tourists each year for its pristine beaches. Panaji (also called Panjim) is the capital of the state and Vasco da Gama, its largest city. Goa is divided into 2 districts - North Goa and South Goa, which act as administrative divisions. North Goa is the largest district of Goa by population, while the least populated district of Goa is South Goa. The official language of Goa is **Konkani**, while Marathi, Hindi, and English are other widely spoken languages.

## Directorate of Industries, Trade, and Commerce

The **Directorate of Industries, Trade and Commerce (DITC)**, Government of Goa, plays a pivotal role in fostering an inclusive ecosystem for Micro, Small, and Medium Enterprises (MSMEs) while ensuring that industrial growth translates into sustainable local employment. The department underwent a landmark transformation created via **Notification No. 23/1/87-GA & C on September 6, 2002**, when it was bifurcated from the Directorate of Industries and Mines to the Directorate of Industries, Trade and Commerce. This shift effectively decoupled mining administration (now under the Directorate of Mines & Geology) to allow for a dedicated focus on trade, commerce, and industry. The directorate is centrally located on the **Ground Floor of Udyog Bhavan, Panaji (403001)**, serving as a key administrative hub in close proximity to other major Government of Goa departments. The total sanctioned strength of **DITC is 95**.

"Raising and Accelerating MSME Performance (RAMP)" is a World Bank-supported Central Sector Scheme launched by the Ministry of Micro, Small, and Medium Enterprises, Government of India (GoI). RAMP is a strategic initiative aimed at enhancing the performance of Micro, Small, and Medium Enterprises (MSMEs) in India. The objective of the programme is to strengthen MSMEs by enhancing their competitiveness, improving access to market opportunities, fostering innovation, and promoting the adoption of new technologies. The Programme fosters MSME growth, and addresses challenges to ensure a robust and competitive business environment. The Programme envisages to provide comprehensive support to MSMEs, by improving market and credit access, strengthening institutions and governance at the Centre and State, improving Centre-State linkages and partnerships, addressing issues of delayed payments, and greening of MSMEs. The RAMP Programme also seeks to address the challenges faced by MSMEs and support their integration into global supply chains. The Government of India envisions RAMP as a pivotal tool for empowering MSMEs, fostering innovation, and driving economic growth.

### Objectives of the RAMP Programme

The aim of the RAMP Programme is to strengthen institutions and access to markets to enhance MSME Performance. The objectives of the Programme are:

- Strengthening coordination and institutions at the National and State level
- Building and integrating technology platforms
- Enhancing firm capabilities and access to markets
- Strengthening the receivables financing market
- Enhancing guarantee products towards increased greening and gender participation

The **Business Facilitation Center (BFC)** is a key intervention approved under RAMP Goa. The BFCs have been set up to provide **handholding, advisory, and facilitation support** to MSMEs in Goa. The BFCs bridge the gap between government initiatives and MSMEs by offering **professional, domain-specific support** through trained experts, thereby improving access to services and ease of doing business.

Two BFCs are operational at the **4th Floor of the Department of Industries, Trade and Commerce (DITC) office in Panaji, Goa**, which functions as **Points of Single Contact** for MSMEs seeking guidance on schemes, compliances, market access, finance, and business growth.

The UDP addresses key challenges faced by MSMEs such as **lack of awareness, procedural complexity, and limited access to schemes and services**, which have resulted in low uptake of Central and State Government MSME schemes. - Development of **Green Index** to benefit MSMEs at Industrial Estates, and the creation of a **Green Credit Model** for all the Goan MSMEs.

Together, these initiatives aim to create a resilient MSME sector that is both socially inclusive and environmentally sustainable.

SHGs receive handholding support for Udyam registration by connecting with **Business Facilitation Centers (BFCs)** and **Women Entrepreneurship Facilitation Cells (WEFCs)** established under RAMP. Need-based training programmes focusing on **marketing, digital tools, packaging, branding, and export readiness** are conducted to strengthen business capabilities. The **EDII Goa Centre** has been onboarded to organize SHG-focused training programmes, while continuous mentoring ensures that SHGs are able to scale operations, access markets, and function as independent MSMEs.

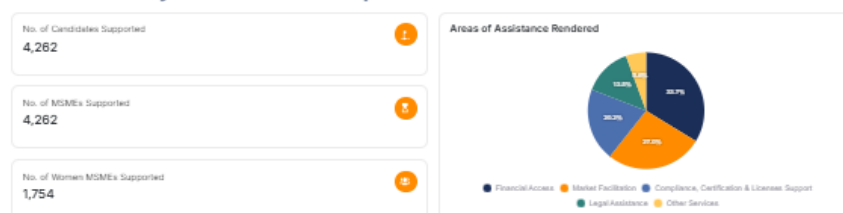
